Please Remember:

Do not pay for a dependent child or spouse who is on an F-2, M-2, or J-2 visa. There is no I-901 SEVIS fee due for a dependent child or spouse for these visa types.

Do not pay again if you know that you have made a mistake after you submitted your information. Instead, send an email to fmjfee.sevis@ice.dhs.gov and explain what information may need to be changed.

Do not click the back button on your browser during your online session. Instead, use the navigation buttons provided on each page.

 - b. You must include the "N" when you type in the number
2. Enter your Last Name/Surname
 - a. This is also listed on your I-20
3. Enter your Date of Birth in the Month/Day/Year format
4. Ensure all of this information is correct on your I-20 and matches your passport. If there is an error, contact your Admissions Representative immediately
